## STANDARD OPERATION PROCEDURES (SOP)

1. <u>Facilities:</u> The Hillsdale Range is available to the public and HR&TF members weather permitting. Dates and times will be posted at the range, and HillsdaleRange.org. Daily range use fees for non-members are; \$15.00 per person, 15 years of age and under are free when under the supervision of a paying adult (18 years of age or older). A Range Safety Officer must be present during live fire. Paper targets are available at the firing line; target style and cost are posted at the firing line. **State Park Vehicle Permits are required to enter the Range** 

2. <u>Authorized Persons</u>: The following persons are allowed to use the range: a. Public and Members of HR&TF who are in good standing.

b. Anyone using the range must sign-in and pay the proper fees.

c. Individuals/groups approved by the club or CRSO on a case-by-case basis. For example, Hunter Education Classes, Law Enforcement training, 4-H clubs, Scout groups etc.

3. <u>Authorized and Prohibited Firearms.</u> All metallic and muzzle-loading firearms may be used except .50 BMG. Fully automatic firearms are permitted with prior approval of the CRSO. No tracer rounds are allowed. Air rifles or pistols are allowed.

**<u>Rifle Range:</u>** All rifles smaller than fifty-caliber BMG may be fired at the rifle range. Pistols of any caliber may be fired at the rifle range <u>but only at the 100-yard targets</u>. Shotguns may be fired with slugs only.

**<u>Pistol Range:</u>** Any pistol/rimfire caliber firearm may be fired at the pistol range. For zeroing, centerfire rifles may use the 25-and 50-yard lines at the RSO's discretion.

#### All shooters will observe the following safety rules:

### A. ALWAYS KEEP THE GUN POINTED IN A SAFE DIRECTION

#### ALWAYS KEEP YOUR FINGER OFF THE TRIGGER UNTIL READY TO SHOOT

#### ALWAYS KEEP THE GUN UNLOADED UNTIL READY TO USE

**B.** Fire only authorized firearms and ammunition.

**C.** Only load firearms on the firing line and after the RSO has given the command that it is a HOT Range.

**D.** No shooting across firing lanes.

E. Any shooter should give the command "Cease Fire" if an unsafe condition occurs.

**F** Firearms must be benched (actions open and facing up, chambers empty, magazines out, and muzzles pointing in a safe direction) before the flashing lights are turned on, and people are downrange. **G** Shoot only from the designated firing line.

**H.** Fire at authorized paper targets held in the provided stands only. No glass, metal, or other targets are allowed,

**I.** Insure all projectiles impact within the established range safety limits.

**J.** Use appropriate ear protection.

**K.** Wear appropriate eye protection.

L. Notify RSO or CRSO of any safety infraction or unsafe equipment.

**M.** Firearms that are out of the case and not being fired must be benched, holstered, magazines out, unloaded and actions open.

N. All shooters are responsible for their guns, ammunition, and other personal property while at the range.

**O.** Police all brass, paper, and other debris after shooting **that is not in front of the firing line**. **Brass and steel cases go in the Brass bucket everything else in the trash cans**.

**P.** Shooters may not consume alcoholic beverages or illegal drugs, or any prescription or over the counter drugs that would impair shooting ability while on range property.

Q. Wash hands with cold water before eating, drinking, or smoking to avoid lead contamination.

**R.** No pets are allowed on the range.

The CRSO or RSO have the right to revoke your membership, if safety rules are violated.
